HAND TRANSPLANTS

Advances in immunosuppressive drugs for transplantation have now allowed for non-life threatening types of transplants to be performed including hand transplants as the hand is crucial to the life of any person. The goal of the procedure is to restore function to the patient with a transplanted hand. The patient will have to undergo clinical evaluations which will include a history and physical examination, x-ray evaluation, psychosocial evaluation, nerve conduction studies, tissue studies and laboratory studies.

Patient Selection Criteria

- Patient between the age of 18 and 60
- Amputated just above the wrist
- Bilateral or dominant hand amputation
- Understands the advantages and risks involved in this surgical technique.
- Recipient should be otherwise healthy and mentally sane.
- Be able to give informed consent
- Resident in the country
- Has family support
- Has local family doctor
- Willing to live in Mumbai city for a year for follow up

Donor Selection Criteria

- Donor selection is similar to selection in solid organ donations.
- Donors will meet the criteria of total and irreversible damage to the brain
- Family will consent to organ donation.
- Size and blood type are the only donor requirements which are mandatory.
- The gender, skin tone, race and age are more of an individual preference than a mandatory requirement.

The Surgery

Hand transplantation is an extremely complex procedure. The surgery can last from 12-16 hours. In comparison, a typical heart transplant takes six to eight hours and a liver transplant, eight to twelve hours. Post-operative complications include blockage of the blood supply, infections and rejection.

Drug Therapy

All hand transplant patients will be on immunosuppressive therapy which includes drugs that must be taken every day for the life of the hand transplant. The immunosuppressant drug therapy is similar to the drugs that are taken by kidney transplant patients. Risk of infection caused by the immunosuppressive drugs may make it necessary for recipients to alter their daily activities particularly in the first six months.

Following the hand transplant procedure, intensive physical therapy will be required to regain hand and arm function.

The patient will also have biopsies and lab evaluations as needed.

Individuals will need to stay in the Mumbai area for a year at least.
