Sub: Starting of MD(Forensic Medicine) course at Seth G.S. Medical College & KEM Hospital, Parel Mumbai under Maharashtra University of Health Sciences, Nashik u/s 10(A) of the IMC Act, 1956 for 03(three) seats for academic year 2013-2014 - Permission of Board of Governors- regarding.

Sir/Madam,

I am directed to refer your proposal for Starting of MD(Forensic Medicine) course at Seth G.S. Medical College & KEM Hospital, Parel Mumbai under Maharashtra University of Health Sciences, Nashik u/s 10(A) of the IMC Act, 1956.

It is to inform that after careful consideration of the scheme and the assessor's report (19th January, 2013), the Board of Governors have come to the conclusion that the Letter of Intent for Starting of MD(Forensic Medicine) course with annual intake of 02(two) students per year as per available facilities, with prospective effect i.e. from the academic session 2013-14 at your Institute u/s 10(A) of the IMC Act, 1956 may be issued.

This Letter of Intent is subject to fulfillment of the following conditions:-

1. The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings, equipment and hospital facilities as per Medical Council of India norms.
2. I am further directed to inform that you and your institution are fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material, etc. throughout the academic year, as stipulated in Postgraduate Regulation of Medical Council of India. In case false/wrong declaration or fabricated documents have been used for procuring permission of the Board of Governors for the starting/increased intake and the said misconduct is brought to notice or comes to the knowledge of Medical Council of India at any stage during the current academic year, your institution is not liable to be considered for increased intake for the next academic year and this letter of permission for the increased intake/starting is also liable to be revoked for current academic year. Besides, Medical Council of India is entitled to take all such measures against you and your college/institution as permissible under the law.
3. No student should be admitted in the above courses till the formal permission of the Board of Governors is granted.
4. The applicant should provide Bank Guarantee of required amount wherever required in favour of Secretary, Medical Council of India, New Delhi valid for three years from a nationalized/scheduled Bank as per MCI's norms against increased intake/starting of above said course. However, Bank guarantee is not applicable for Government institution.
5. It may be noted that the Letter of Permission will not be issued if Bank Guarantee for required amount from a schedule bank is not submitted in order and within time. The Bank Guarantee submitted by the institute if not in order, will be returned.
6. The college has to give an undertaking that the students admitted to this course shall be paid stipend on par with the stipend being paid to the Postgraduate students of State Government Medical Institutes/Central Government Medical Institutions, in the State/Union Territory where the institution is located as required under Clause 13.3 of the Postgraduate Medical Education Regulations.

I am directed to state that the Board of Governors, Medical Council of India at its meeting held on 22.08.2013 considered the assessment report (May, 2013) on the standard of examination and other teaching facilities available at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai for Recognition of MD(Immuno Haematology & Blood Transfusion) qualification granted by the Maharashtra University of Health Sciences, Nashik and it was decided as under:-

"The Board of Governors considered the assessment report (May, 2013) and decided to recommend that MD(Immuno Haematology & Blood Transfusion) qualification granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai be recognized and included in the 1st Schedule to the L.M.C. Act, 1956 restricting the number of admissions to 02(Two) students per year."

The attention of the institute is drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be reviewed.
- 6.6 Failure to work timely renewal of recognition as required in sub-clause 4 shall necessarily result in stoppage of admissions in the concerned Post Graduate Course.

You are requested to issue notification recognizing the above qualification on or after May, 2013.
