Sir,

I am directed to state that the Board of Governors, Medical Council of India at its meeting held on 03.09.2013 considered the assessment report (August, 2013) on the standard of examination and other teaching facilities available at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai for Recognition of DM(Neonatology) qualification granted by the Maharashtra University of Health Sciences, Nashik and it was decided as under:-

"The Board of Governors considered the assessment report (August, 2013) and decided to recommend that DM(Neonatology) qualification granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai be recognized and included in the 1st Schedule to the L.M.C. Act, 1956 restricting the number of admissions to 01(One) student(s) per year."

The attention of the institute is drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 *The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.*
- 6.6 *Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.*

You are requested to issue notification recognizing the above qualification on or after 2012.
