"The Postgraduate Medical Education Committee considered the Council Assessor's Report (26th & 27th August, 2016) and decided to recommend to the Central Government that MD(Forensic Medicine) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

You are therefore requested to notify the above qualification at the earliest.


