

The College authorities may take up the matter for recognition of the qualifications under Section 11(2) of IMC Act at the time of first batch admitted against the course appears for final year examinations.
- It shall be ensured by the States & UTs/Medical Colleges/Institutes concerned that:
 - Adequate funds are provided in Budget regularly till all facilities are provided.
 - 50% Seats are contributed to All India Quota (Except the Colleges in Jammu & Kashmir).
