**Sub: Maharashtra University of Health Sciences, Nashik - Recognition of Diploma in Diabetology qualification for 1 seat in respect of students being trained at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai.**

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Council Assessor's Report (25th July, 2016) on the physical and other teaching facilities available at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai for the award of Diploma in Diabetology qualification for 1 seat under Maharashtra University of Health Sciences, Nashik. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (25th July, 2016) and decided to recommend to the Central Government that Diploma in Diabetology qualification for 1 seat granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.

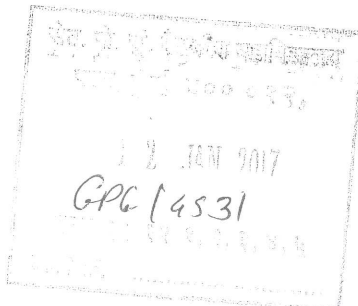
