

Sir/Madam.

I am directed to inform that the compliance verification assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S. Medical College, Mumbai was carried out by the Council assessors on 06th February, 2018. The said assessment report along with previous assessment reports (26th July, 2017, 8th March, 2017 and 22nd & 23rd Feb., 2016) was considered by the Executive Committee at its meeting held on 05.03.2018 and it was decided as under:-

"The Executive Committee of the Council considered the compliance verification assessment report (06th February, 2018) along with previous assessment reports (26th July, 2017, 8th March, 2017 and 22nd & 23rd Feb., 2016) and decided to recommend that recognition of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S. Medical College, Mumbaibe continued restricting the number of admissions to 180 (One Hundred Eighty) students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time. which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."
