## Introduction

The Seth GS Medical College and KEM Hospital, Diamond Jubilee Society Trust was established in 1989 with the following objectives:

- C) To provide medical relief and undertake development programmes in health services and upgrading health care facilities to various sectors of the society.

#### **Activities of the trust**
