Eligibility Criteria & Document submission:

- a. Interested Applicants in the above-mentioned work should be architects of repute having at least 10 years of experience, i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies• act 2013, the architects should be registered with council of architecture.
- b. A document in support of Registration under Maharashtra 'VAT' Act 2002, Sales Tax, or GST Registration Certificate in Maharashtra (or equivalent requirement under VAT). Those not registered in Maharashtra shall submit an undertaking to the effect that if they are successful tenderer, they shall submit Sales Tax Registration Certificate in Maharashtra within 15 days of issue of work order, failing which payment for the work executed will not be released.
- c. Certified copies of valid 'PAN' documents and photographs of the individuals, owners, Karta of Hindu undivided Family, firms, private limited companies, registered co-operative societies, partners of partnership firms and at least two Directors, if number of Directors are more than two in 'case of Private Limited Companies, as the case may be.
