#### Please note the following

1. The appointments are purely temporary and on a project basis only. The selected candidate will abide by rules of Department of Clinical Pharmacology and will not be employees of the Municipal Corporation of Greater Mumbai or the sponsor.
2. Tenure: It is tenable for 12 months and only from the date of joining duty and is a contractual appointment. The appointment would automatically cease after completion of 6 months or earlier in case of discontinuation of this project.
