Diamond Jubilee Society Trust Department has been working hard to raise funds to upgrade & renovation of Various departments in KEM Hospital, with the objective of providing state of the art facilities to the underprivileged sections of our society.

The Dean KEMH wishes to create a "New Inborn Neonatal Intensive Care Unit (NICU)" with necessary infrastructure near the delivery ward which will provide services to very sick newborns. The department caters to over 7000 deliveries and 1500 neonatal intensive care admissions per year. Presently, NICU is located on the 10<sup>th</sup> floor of the new multi-storied building where as delivery happens in the department of Obstetrics and Gynecology which is located in the old three-storied building. **INSTRUCTIONS TO APPLICANTS**

Eligibility Criteria & Document submission:

- a. Interested Applicants in the above-mentioned work should be contractors of repute, multi-disciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/Private Limited Companies / Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered in with the Municipal Corporation of Greater Mumbai, (MCGM) in Class 'AA' as per old registration 2015 or in Mechanical & Electrical Class 'A' as per new registration 2016 and should have a valid PWD License.
- b. A document in support of Registration under Maharashtra VAT' Act 2002, Sales Tax, GST Registration Certificate in Maharashtra (or equivalent requirement under VAT). Theme not registered in Maharashtra shall submit an undertaking to the effect that if they are successful tenderer, they shall submit Sales Tax Registration Certificate in Maharashtra within 15 days of issue of work order, failing which payment for the work executed will not be released.
- c. Certified copies of valid 'PAN' documents and photographs of the individuals, owners, Karta Hindu undivided Family, firms, private limited companies, registered co-operative societies, partners of partnership firms and at least two Directors, if number of Directors are more than two in case of Private Limited Companies, as the case may be. **Work Completion/Delivery period:** The work completion period will be 75 days from date of Commencement.
