Eligibility and Conduct of Tasting Round – EOI for Mess & Catering Services

Conduct of Tasting Round

The tasting round will be conducted within the institute premises as per the details below:

- **Venue:** Dean Office/ Main Boys Hostel
- **Date:** 15-July-2026
- **Time:** 11:00AM to 1:00PM

Each eligible vendor shall:

1. Prepare food in their own licensed kitchen and bring properly labelled, temperature-maintained samples of the following items:
 - One **Breakfast sample plate.**
 - One **Standard Veg Thali** sample (as per EOI Appendix – A).
 - One **Chicken Thali** sample
 - One **Evening Snack** item.

2. Ensure that:
 - All food is freshly prepared.
 - Food is transported in clean, food-grade containers.
 - Serving staff are in proper uniform and comply with hygiene norms.
3. Serve samples in individual plated portions to the tasting panel using disposable plates and spoons at the venue.

Important Instructions for Vendors

1. Attendance at the tasting round on **15-July-2026** is **mandatory** for all eligible vendors. Non-attendance will lead to disqualification from further consideration.
2. No vendor shall serve or distribute food samples outside the designated venue during the tasting round.
3. All other terms and conditions of the original EOI remain unchanged and fully applicable.
4. Any violation of hygiene, safety, or conduct norms during the tasting round may attract penalties as per the EOI Penalty Schedule and may lead to disqualification.
